#### Boston to receive £20 million additional funding

Boston is to benefit from £20 million funding from the Government towards regenerating the town, growing the economy and tackling anti-social behaviour.

The Prime Minister Rishi Sunak has made the announcement as part of 55 "overlooked" towns given a £20 million endowment-style fund - each to be spent over a 10-year period.

Businesses and local people in Boston - as well as Spalding and Skegness which will also receive £20m funding each - will be instrumental in driving forward the future improvements and regeneration of their towns, with the fund aiming to boost local people's pride for where they live and work.

The additional funding for each of the Partnership's sovereign Councils comes after £20 million Levelling Up funding for Spalding; £21.9 million Boston Town Deal funding; £14.8 million Levelling Up funding for Boston and £24.5 million Town Deal funding secured for Skegness.

In a joint statement, Cllr Nick Worth Leader of South Holland District Council; Cllr Anne Dorrian Leader of Boston Borough Council and Cllr Craig Leyland Leader of East Lindsey District Council said: "This is fantastic and unexpected news for each town, our councils and the wider South & East Lincolnshire Councils Partnership. "We welcome that the Government has again recognised Spalding, Boston and Skegness when making this national funding announcement and now there is work to be done to understand more about how this money can be used. Our next steps will be to gain a full understanding of how these funds will help to support our high streets, businesses and communities.

"We look forward to working out the finer details in the coming weeks and months, and then beginning that serious work with our communities and businesses as soon as we can."

#### Boston Borough Council makes pledge to be Age-friendly employers

Boston Borough Council has signed the Age-friendly employer pledge, organised by the Centre for Ageing Better. 44% of the workforce across the South and East Lincolnshire Councils Partnership is aged over 50, and the pledge displays commitment to improving work for people in their 50s and 60s, by recognising their value and expertise.

The pledge shows our commitment to improving work for people in their 50s and 60s, recognising their value and expertise and to help make our workplace even more age-friendly.

This means we are taking action to improve our recruitment as well as the retention and development of workers across the partnership.

Nationally, most people are working later in life but older workers can often face prejudice and are overlooked. At the same time, the job market is changing with many sectors struggling with skills and labour shortages. In signing the pledge, the partnership recognises that older workers are often key to filling these gaps. The Partnership is proud to have a good record for employing and retaining older workers and is committed to improving this even more going forward.

Cllr Anne Dorrian, Leader of Boston Borough Council said: "It is important that the South & East Lincolnshire Councils Partnership is recognising the value those aged over 50 bring to our workforce. Older workers often bring a wealth of experience and knowledge to teams, and in many instances they become role models to their peers and those just starting out in their careers.

"There is a lot everyone can learn from a multigenerational workforce and I am very proud the Partnership has made this pledge to show its commitment."

#### Boston Residents asked for thoughts on 2024/25 Council Tax Support Scheme

Residents in Boston Borough are being asked to share their views on the council's proposed Council Tax Support Scheme for next year.

The scheme is a way of helping people on low or no income to pay their annual council tax bill. The overall cost of the scheme is around £3.7million with Boston Borough Council supporting around 2,500 working age households. An online consultation has been launched as each year, the Council must decide whether to change the scheme for applicants who are of working age.

The council is proposing to keep the Council Tax Support scheme the same for 2024/25 as it is now in 2023/24 and is seeking views on whether it should up-rate the scheme for working age claimants in line with the Department for Work and Pensions provisions for Housing Benefit.

This will apply to all Council Tax Support claimants and will keep the local Council Tax Support scheme aligned with national welfare provisions.

The maximum support available to working age applicants is 75 per cent, meaning that all working age households have to pay at least 25 per cent towards their Council Tax.

Pensioners are not affected by any changes made to the local Council Tax Support Scheme as the rules for applicants of pension age continues to be set by Central Government. Pensioners can continue to get up to 100 per cent discount on their Council Tax.

War Disablement Pensioners as well as war widows and war widowers are also protected.

The means-tested scheme allows for vulnerability within the calculation, including people with children, disabilities or caring responsibilities.

The council tax collected by Boston Borough Council goes towards Borough services (and a share to Internal Drainage Boards), Lincolnshire County Council, Police and Crime Commissioner, Parish Councils and BTAC Special Expenses.

#### Changing Places toilet opens at the Cattle Market Car Park on Wide Bargate.

A 'Changing Places Toilet', next to the main public toilets, has officially opened.

Standard accessible toilets meet the needs of some disabled people – but not all. Changing Places Toilets have larger facilities that have the right equipment, including a changing bench and a hoist, designed to support disabled people who need assistance. This was made possible by funding from central government as part of the Changing Places Fund.

It is the third Changing Places UK to be opened in Boston with the first at Central Park, and second in Lincoln Lane car park, Boston.

Bespoke access control measures have been installed, to keep the toilets as safe from vandalism as possible, and ensure they are always available.
