Councils vote to proceed with devolution

At our last Full Council meeting, Lincolnshire County Council voted to pursue a devolution deal for Greater Lincolnshire, which was followed by similar votes at North and North East Lincolnshire Councils. All three councils see this as a great opportunity to be the masters of our own destiny and not be left behind when it comes to government investment. The Secretary of State will now consider the final proposal, and if approved, will instigate secondary legislation.

Council challenges pylon plan

Lincolnshire County Council's executive are commissioning an independent report into the impacts of National Grid's proposal to erect 420 pylons around 50m high, through the Lincolnshire countryside.

At a meeting held on 5 March, the executive agreed to put in a formal objection to the scheme that would see 140km of high voltage electricity cables, pylons and substations run through the county from Grimsby to Walpole in Norfolk.

An independent analysis is also being commissioned to look at the impacts the pylons could have on Lincolnshire including putting farmland out of use, the visual impact on the flat landscape, the effect on tourism and air traffic limitations.

Buy With Confidence - making local businesses stand out

Lincolnshire businesses are encouraged not just to tell their customers they're trustworthy, but to show them, by joining the national 'Buy With Confidence' scheme.

Businesses signed up to the scheme are vetted by Lincolnshire Trading Standards, making them stand out as trustworthy and reliable. Customers can search the Buy With Confidence database to find approved local tradespeople, and each business signed up to the scheme has a dedicated page on the site and can use the 'Trading Standards approved' logo. With half price memberships available until April 2025, businesses are encouraged to **sign up now** and see their reputation soar.



New Technical Rescue Vehicles

Lincolnshire Fire and Rescue have seven new Technical Rescue Vehicles (TRVs) – vans that carry specialised equipment for incidents such as water rescue and animal rescue. The previous rescue units had reached the end of their serviceable life, and have been replaced with bigger and better vehicles that are also more efficient. The new TRVs will be stationed strategically around the county to provide maximum coverage and optimum response. They attend specialised activities such as RTCs involving heavy vehicles, incidents involving large animals or water related incidents where there is a danger to life and also enhance and support general operations. County council announces Community Crossings Initiative

Over ten Lincolnshire crossings will be built over the next eighteen months as part of the new county council project.

The Community Crossings Initiative will cost £3.8 million in total, with £1.5 million earmarked by Executive in 2023 and the remaining coming from a combination of additional county council funding and developer contributions.
