This year, all of our centres welcomed Community RePaint stores - letting residents pick up free paint, save money, and help cut down on waste. At our Tattershall centre, you'll find the county's first Reuse Shop, where pre-loved items get a second chance, and the Baby Bliss Baby Bank, supporting families by rehoming essential baby and toddler items while reducing waste.

# School admissions policy and Lincolnshire co-ordinated schemes consultation 2027/28

Lincolnshire County Council is seeking your input on a proposed change to the Lincolnshire co-ordinated scheme 2027/2028 and a proposed change to the admissions policy for maintained schools for the 2027-2028 school year.

We are consulting on:

- A proposed change to the co-ordinated schemes to increase the number of school preferences that applicants are able to name on their application forms from three to four.
- Changing the Published Admissions Number (PAN) at Quadring Cowley and Brown's Primary School reducing the minimum number of places from 16 to 15. We're suggesting this change to help schools better comply with regulations that limit infant class sizes to 30 pupils.

### They are the champions

The winners of the Greater Lincolnshire Apprenticeship Champion Awards have been announced, recognising the outstanding achievements of apprentices, trainers, and employers across the region. Held at The Drill, Lincoln, the award ceremony brought together finalists, training providers, employers, and local leaders to celebrate apprenticeship success.

The top honour went to Melanie Papworth who was named Apprentice Champion. Melanie completed a senior leader apprenticeship while raising four children, overcoming significant challenges and becoming a passionate advocate for apprenticeships in Greater Lincolnshire.

### Safeguard your sanctuary

Last year, Lincolnshire Trading Standards received 650 complaints about home improvement work, including roofing, windows, doors, paving, driveways, and patios. Residents paid nearly £7.5 million, averaging £11,500 per job.

Our homes are our sanctuary, so investing in them makes sense. However, with autumn and winter approaching, be cautious, offenders may exploit poor weather to target homeowners.

#### Get help to find trusted trades people on the Connect to Support website.

#### Top tips:

- Research: Ask for recommendations, read reviews, and speak to previous customers.
- Specify your needs and get quotes from at least three businesses.
- Only pay for completed work unless using a secure payment service. Upfront material costs may be reasonable.
- Get everything in writing, including changes.

### Protecting your family: medication safety matters

Residents are urged to protect their families by storing and disposing of medicines responsibly. Each year, thousands are harmed by taking medication not prescribed to them, including children and adults. Even common medicines can cause severe allergic reactions, dangerous interactions, or overdose when misused.

To prevent accidents, **NHS Lincolnshire ICB** and Lincolnshire County Council recommend:

- Store medicines out of sight and reach, ideally locked away
- Keep them in original packaging with clear labels
- Never leave loose tablets in bags or drawers
- Dispose of unused or expired medication safely most pharmacies offer free disposal
- Talk openly with family members about the risks

In an emergency, call 999 if someone is unconscious or struggling to breathe. Otherwise, contact NHS 111, on the phone or **online**.
